Having attained the performance requirements specified in Test Report N° 2018EP1052UE and the PPE's Technical Documentation.

Description of the PPE:

A polo shirt made in grey knitted fabric. FRONT: a single component open at the throat. The opening fastens with three acetate buttons covered by a flap. BACK: straight. SLEEVES: long, shirt-type, the cuffs adjust with grey elasticated knitted fabric. COLLAR: shirt-type, made with grey elasticated knitted fabric.

The component materials of the PPE according to technical documentation presented by the client are:

- Grey knitted fabric composition: 78% viscose FR, 20% para-aramid and 1% carbon with an approximate weight of 240 g/m².
- Grey / navy blue elasticated knitted fabric (cuffs and collar), 53% modacryl, 44% cotton and 3% antistatic fiber with an approximate weight of 245 g/m².
- Acetate button
- · Yarn for stitching

The PPE may carry the following variants:

It can be manufactured in all the colours included in the range certified by Oeko-Tex.

It shall be the manufacturer's sole responsibility to furnish specific information pertaining to this certificate and the tested levels of protection.
